OPA's Fifteenth Annual National Exhibition will be held at the Dana Gallery, in Missoula, Montana. Located in the heart of Western Montana's stunning natural landscape, Missoula is a vibrant town offering visitors a wide variety of activities and cultural events, including unsurpassed painting opportunities. The opening reception and awards ceremony will take place on Friday May 5, 2006, from 5:00 p.m.—9:00 p.m.

Our goal is to assemble the finest display of representational art in the history of Oil Painters of America. The focus in the jurying process will be to select paintings that show the highest quality in drawing, color, and composition, emphasizing a diversity in representational style and subject matter. We invite you to submit a truly exceptional piece. Your participation in a show of this caliber will be an exciting way to start the new year.

The awards this year will be extensive and consistent with previous years, thanks to the generosity of loyal friends of OPA. The total awards are estimated to be in excess of \$35,000 including a \$15,000 American National Award of Excellence.

The awarding juror for our Year 2006 National Show will be Master Signature member Peter Adams OPAM. Since 1993, Adams has served as president of the prestigious California Art Club, which is recognized as a leading proponent in the current national traditional art movement.

Liabilities and Responsibilities

Oil Painters of America and Dana Gallery will not be responsible for loss or damage of any artwork, no matter what the cause. By submitting artwork to this exhibition, each artist will be deemed to have concurred with this agreement. Artists pay for shipping both ways. We suggest that you provide insurance to cover the full value of the artwork while in transit.

William Chambers OPA, Signature Member and Vice President, will serve as chairman of a Jurying Committee consisting of five highly qualified artists. The jurors will be Master Signature or Signature members of OPA. The results of the jurying will be final. No refund of entry fee on unaccepted slides. Participants will be notified promptly of the jurors' selections.


FINAL ACCEPTANCE DATE: Tuesday, January 17, 2006

Please note: FedEx does not deliver to a post office box.

- Representational oil paintings of original concept and design only.
- Canvas size not to exceed 30" x 40". (Not applicable to Masters.)
- Painting must be framed and wired for hanging.
- Submit one slide and one photo of the same painting.

Print large or type on entry form, slide and photo.
No handwriting please. Use first and last name only.

Example of accepted format
for titling your slide

Mail with one slide and photo (4"X6") of your unframed oil painting, entry fee, entry and notification forms, together with a stamped, self-addressed business size envelope (4-1/8" X 9-1/2"). **Print clearly** on photo and slide: your name, title of painting, size, and price. Place a red dot in upper right, front corner of slide. **Slides without this full information will not be accepted.** Slides should be 35mm with a cardboard or thin plastic mount with no labels or tape. Declined slides and photos will be returned. Accepted slides become part of OPA archives and may be used for future OPA event promotion. **Do not paperclip slide to your entry.**

All entry material should be sent to OPA in a business size No. 10 envelope. Painting entered should be of current work and should not have been submitted for a previous OPA national exhibition.

ENTRY FEE: ONE ENTRY ONLY

A \$20.00 fee provides for jurying. Please make your check payable to OPA and mail to: OPA, Post Office Box 2488, Crystal Lake, IL 60039-2488.

In addition you must be a paid member through December 31, 2006 at a cost of \$60.00. This will also enable you to receive one color show catalog, newsletters and participate in Regional Shows in your area. **Please include a separate check for membership dues** made payable to OPA. If you have already paid your membership dues for the year 2006, please disregard this membership fee. **Include entry form, and all checks in the same envelope.**

Sales commission of 40% is required by the gallery for all paintings sold. Please take this into consideration when setting your price. All work that is submitted must be for sale. **NO NFS.**

DELIVERY OF ACCEPTED WORK

Local Artists deliver uncrated paintings to: Dana Gallery, 246 N. Higgins Missoula, MT 59802 between April 17 and April 21, 2006.

Out of Town Artists ship to: Dana Gallery, 246 N. Higgins, Missoula, MT 59802, to arrive between April 17 and April 21, 2006.

Include a **\$20.00 check payable to Dana Gallery**, to cover the labor expense for uncrating, storage of crates, re-crating your painting and contacting your shipper for return. **In a separate envelope, include a check made out to Dana Gallery, to cover the cost of return shipping. Place both envelopes inside the shipping container.**

Opening Gallery Reception and Awards Ceremony: Collectors, press, OPA members and invited guests. RSVP appreciated but not required. 5:00 P.M. to 9:00 P.M.

May 5th through June 13th

Length of time show will be open for viewing. Gallery Hours: 10:00 A.M. to 6:00 P.M. Monday through Saturday; 11:00 A.M. to 4:00 P.M. Sunday.

June 14th through June 19th

Local artists must remove paintings between 10:00 A.M. and 6:00 P.M. Monday through Saturday; 11:00 A.M. to 4:00 P.M. Sunday. Otherwise, a storage fee will be charged. Dana Gallery appreciates your cooperation.
