**IMPORTANT NOTE:** Please be sure to include a \$25 check payable to Mountainsong Galleries for uncrating and storing your box. Also, PLEASE be sure to include a return shipping label and attach your notification card to the back of your painting.

## **CORRECTIONS TO PAINTING TITLE, SIZE AND PRICE**

You will be receiving a notification card that should be attached to your painting prior to shipping. PLEASE read the notification card carefully to ensure that all of the information is correct. While we do not make any title or price changes we will make spelling and/or size corrections, as well as change any blatant pricing errors (i.e., a zero is missing on the end). ## **REQUEST FOR BIOGRAPHICAL STATEMENT**

## **DELIVERIES**

- All shipped work should arrive July 14 - July 19, 2014.
- Shipments from OUTSIDE the United States must be shipped "Free Domicile" or they WILL NOT BE ACCEPTED.
- Include a check payable to Mountainsong Galleries in the amount of \$25 to cover the cost of uncrating, storage of crates, re-crating your painting and shipping arrangements. **Please Note: The gallery is not obligated to hang paintings that arrive without the uncrating fee enclosed.**
- **Shipping Address is: Mountainsong Galleries, Ocean Avenue 3 SE San Carlos, Carmel-by-the-Sea, CA 93921-3396.** Please include the gallery's telephone number on your shipping label (831) 626-0600. \*Please note this address is only to be used for FedEx and UPS deliveries. Gallery's street address and mailing address via the postal service are different.
- Hand Deliveries should be dropped off between August 19 and August 23, 2014. Gallery hours: Monday - Saturday: 10:00 a.m. to 6:00 p.m., Sunday: 12:00 p.m. – 6:00 p.m.

- Crates must be sturdy, reusable, top-hinged, and fastened with screws (not nailed). Sturdy cardboard cartons may be used.
- **No Peanut Packing!** Please ensure your artwork is securely wrapped / packaged.
- ARTISTS- PLEASE USE HEAVY DUTY PICTURE WIRE ON ALL PAINTINGS.
- Mountainsong Galleries is not responsible for damage to paintings while in transit. **We suggest that you provide insurance to cover the full value of the artwork while in transit.**
- **Please secure your notification card to the back of your painting.**

### **RETURNS**

- Hand delivered work must be picked up by the artist between the dates of October 2 – October 4, 2014. Gallery hours: Monday - Saturday: 10:00 a.m. to 6:00 p.m., Sunday: 12:00 p.m. – 6:00 p.m.
- The cost of shipping the painting both to and from the show is the responsibility of the artist.
- **If using FedEx Ground or Fed Ex Air:** you may generate a PRP (Package Return Pickup Label) and include with your artwork. It will not be activated/charged to your account until picked up and scanned by FedEx. Please note: you must have your own Fed Ex account to generate a return pickup label. If you need to establish an account you may call: 1-800-503-1428 or go on-line to [www.fedex.com](http://www.fedex.com).
- **If using UPS:** if you have an account, you may fill out a ground or air shipping document and include it with your painting. You can also generate an ARS (Authorized Return Service Label) and include with your artwork; however, the cost for obtaining the ARS label is immediately charged to your account. That being said, if the label is not used, you can call and have it voided. Go to [www.ups.com](http://www.ups.com).
- **DO NOT** send paper return shipping forms unless your FedEx or UPS account number **and** your return address are on the form.
- **DO NOT send checks** to pay for the return of your work. **No COD's on return shipping.**
- Work will be repacked and returned in the same crates or cartons if possible. If packing materials are inadequate for return shipment, Mountainsong Galleries, may request additional fees to cover the cost for new shipping materials.
- **Be certain to adequately insure your painting while in transit. Provide adequate fees in your return shipping amount to provide for insurance coverage.**

### **LODGING**

A block of rooms has been reserved at the Pine Inn. When making your reservation, please reference "Oil Painters of America". There is limited parking available at the Pine Inn on a first-come, first-served basis. Additional parking is available on the street.
