Once a Methodist Church, the art center is expansive. The original chapel is now a full size auditorium which was the perfect venue for the many educational events presented over the weekend. Not only was there abundant space for the 400 paintings in this year's show, but plenty of space beyond that to tastefully display over 100 plein air paintings done throughout the week.

The board members and staff of the art center, along with a small cadre of dedicated volunteers from Petoskey and beyond, rolled out the red carpet for OPA members and guests. It was all in the details! From attractive canvas bags provided at check-in, to a beautiful full-colored catalog, to the artist's lounge featuring an impressive table spread including specialty coffees and chocolates - the artists felt appreciated and welcome throughout their stay in Petoskey.

Other presentations included a lecture by lawyers Matthew Bower and Rick Herman on how to use intellectual property rights to your advantage. And finally, Eric Henenway, Director of Cultural Preservation for the Little Traverse Bay Band of Odawa Indians and Michael Federspiel, Director of Little Traverse Historical Society, shared the history surrounding the Little Traverse Bay area.

JUROR OF AWARDS STATEMENT By Thom Robinson OPA

It was a special honor to be chosen to judge the OPA Salon Show in Petoskey, Michigan. I spent many holidays with my grandparents who lived near Petoskey as I was growing up.

I was impressed to see a show of 375 paintings of the highest quality in one of the best gallery spaces I've visited, which made it a real challenge to pick so few paintings for awards. I enjoyed spending many hours going over all the paintings, which ranged from realism to impressionism including all types of painting styles.

In judging I looked for paintings done with confidence in the handling of paint, composition, design, color, value and movement. I tried to be objective in evaluating the paintings, looking at all the paint manipulation and how the edges were done.

Thanks to the Crooked Tree Arts Center and to the Oil Painters of America for organizing such an impressive event.

MEET THE ASSOCIATE AND SIGNATURE GOLD MEDAL WINNER VADIM DOLGOV

Vadim Dolgov graduated from the Orenburg Academy of Fine Arts in Orenburg, Russia. His style strongly resembles that of the great masters of late 19th and early 20th century realists. Vadim's work began to get serious recognition in 1991. Since then his paintings have been exhibited and sold throughout the world. In 1998 he and his family moved to Toronto, Canada where he now lives and works.

Looking at his many varied, beautiful pictures, one can almost touch the textures, feel the sunlight and the wind, hear the sounds, and breathe the air of the images before them. His portraits and figurative scenes are a study of the minute nuances of facial expressions and body language, that draw the observer into the mood of the model.



MEET THE MASTER SIGNATURE GOLD MEDAL WINNER JOHN MICHAEL CARTER

John Michael Carter was born in Chicago, IL. He began his first studies in drawing at the age of 16 with his father E.L. Carter, a commercial artist. In 1968, he attended the American Academy of Art in Chicago. In 1970, Mr. Carter moved to Los Angeles where he attended the Art Center College of Design. There he received a background in the major classical schools of painting and graduated with a B.F.A. Degree in 1972. For ten years, Mr. Carter taught drawing and painting for the University of Kentucky at Jefferson Community College in Louisville, KY.

Mr. Carter has shown paintings in many national exhibitions and competitions including Arts for the Parks, the 1991 Hubbard Museum Award for



Excellence Exhibition and the Artists of America show in Denver. His portrait "Hannah" was a finalist in the 2002 P.S.O.A. International Portrait Competition and "Jolie" was a finalist in 2003. He received first prize and the Artists' Choice Award for his portrait "Sarah" at the 2002 A.S.O.P.A. International Portrait Competition. Mr. Carter received *The Artists Magazine* Award for his painting "Summer Reading" at the 2003 OPA National Exhibition. His painting "The Yellow Canary" won first prize at the 2004 OPA National Exhibition. "The Dressing Table" was awarded Best Impressionistic Oil at the 2004 Hoosier Salon. "Romanian Girl" was a finalist in the 2005 Portrait Society of America International Portrait Competition. He received first prize at the 2005 Hoosier Salon for his painting "Reading on the Veranda".

MEET ON-LINE SHOWCASE WINNER NIKOLO BALKANSKI

Nikolo Balkanski's paintings bring his European origin and training to his art, and his post-impressionist interpretations carry a distinctive quality that easily captivates the viewer with his portrayal of the subject using sophisticated color and remarkable draftsmanship. Balkanski, an internationally recognized portrait and landscape artist from Sofia, Bulgaria, lives and works in Colorado. Since his move to the United States in 1984, from Helsinki, Finland, his work has undergone a natural metamorphosis.

One sees at a glance that Mr. Balkanski is schooled in the techniques of the old masters and possesses the exceptional talent to employ their methods in creating thoroughly modern paintings. It is therefore no surprise that he is highly regarded by his peers, museum curators, and prominent art collectors.



As noted by U.S. ART "Unfettered by self-imposed limitations, Balkanski applies his well-developed skills to subjects as disparate as landscapes, nudes, portraits, still lifes and more. His style, technique and especially his use of color result in images that are more painterly than art that most collectors may be accustomed to seeing."

SCHOLARSHIP WINNER DENISE IMKE RECAPS HER EXPERIENCE

I just wanted to report that I have completed the Cynthia Rowland Portraiture workshop that I chose to use for my OPA Shirl Smithson Scholarship.

It was, hands down, one of the best workshops I've ever taken and I sincerely appreciate OPA and the Scholarship Committee for affording me this opportunity.

The workshop was very structured and organized without a minute wasted. We were presented with a different model every 3 hours.

Cynthia's approach was to begin with grisaille paintings the first day using burnt sienna plus white. Then day 2 we used burnt sienna, ultramarine blue plus white. Day 3, we





added a red, day 4 we added a yellow, then on day 5 we used a full palette. The time spent during model breaks was spent either demo-ing by Cynthia or discussing a specific point. Without question, this workshop advanced my skill level and fostered a new passion for painting the portrait.

The workshop was held at the New Mexico Art League in Albuquerque, New Mexico which is a wonderful facility; one that I hope to revisit in the future.

SHIRL SMITHSON MEMORIAL SCHOLARSHIP AVAILABLE TO ASSOCIATE MEMBERS AND ART STUDENTS

The Shirl Smithson Memorial Scholarship was first awarded to one artist in 2003 and is now awarded to three active Associate members and one part or full-time student currently enrolled in art school or an art related program. (Students need not be OPA members to apply.) Applicants are judged on the quality and strength of his/her artwork and the potential for further career development.

Scholarships are awarded to attend a workshop or class in representational oil painting. Award winners must receive approval from OPA prior to enrolling or attending a workshop or class.

Scholarship applications must be received in the OPA office no later than December 1st for review by the Scholarship Committee and approval by the Board of Directors. Each application must include: a cover letter, one page resume, and two CD's, each containing six images of applicant's representational work in oils. Students must include a letter from his/her instructor acknowledging that he/she is currently enrolled as an art student. 




